



Rental Terms and Conditions

Nvision Solutions LLC/Le Fabuleux Events hereby rents to _____ (the customer) the property described on invoice # _____ which is subject to the following terms and conditions. The customer in consideration thereof, acknowledges and agrees as follows:

Security Deposit and Rental Deposit: To secure your reservation, a non refundable security deposit of \$75.00 (if balance is less than \$1,000) or \$150.00 (if balance is more than \$1,000) must be taken at the time of reservation. The security deposit will be applied towards your final bill.

Inspection: The customer acknowledges that he/she will personally inspect all rental items, finds them suitable for his/her needs, in good condition and notify Nvision Solutions LLC/Le Fabuleux Events at least three hours prior to start of event of any defects including but not limited to incorrect chair cover or linen size, incorrect colors, malfunctioning equipment etc. A remedy will be made at the discretion of Nvision Solutions LLC/Le Fabuleux Events. We can not address any issues with rentals or equipment after the customer uses the items during the rental time period or after start of event.

Warranties: There are no warranties of fitness, quality or durability either expressed or implied. There is no warranty that the rental items are free of any defects. Nvision Solutions LLC/Le Fabuleux Events can not guarantee color dye lot on all rental items. In the event that your rental items could not be delivered or utilized due to circumstances that we deem beyond the control of Nvision Solutions LLC/Le Fabuleux Events (i.e inclement weather, power outages, delivery delays, venue hindrances etc.) a remedy will be made at the sole discretion of Nvision Solutions LLC/Le Fabuleux Events. Nvision Solutions LLC/Le Fabuleux Events shall not be held liable to customer for any loss or damage caused directly or indirectly by the rental property, by any inadequacy thereof, or defect therein.

Prohibited Uses: Use of rental items in the following circumstances is prohibited and constitutes a breach of contract: (a) Improper and unintended use or misuse (b) Use by anyone other than the customer (c) Use at any location other than the addresses furnished by the Customer.

Time of Return: Rental items that are not scheduled to be picked up by Nvision Solutions LLC/Le Fabuleux Events must be returned to Nvision Solutions LLC/Le Fabuleux Events the next business day following the event. The customer agrees that all rental items that are not returned after the next business day following the event will be charged an additional rental charge for each day the equipment is not returned.

For items, scheduled to be picked up: No rental items may be moved from the place of delivery without written permission of Nvision Solutions LLC/Le Fabuleux Events. Customer shall have all items available for pickup by Nvision Solutions LLC on the pickup date listed on the invoice. Failure to have said items available will subject customer to an additional rental charge for each day the equipment is not available for pickup. Time is the essence of this contract. Any extension must be mutually agreed upon in writing.

Return/Pick up of all Rental Items: Customer must return all items free of debris, wax, food and damage. Additional laundry, handling, or replacement charges may apply if rented items are returned damaged, broken, soiled beyond reasonable wear or require wax, pin, or knot removal. All equipment is to be knocked down and stacked for pickup. For health purposes, all china, glassware, flatware and other food service equipment must be rinsed in hot water and repacked in the same containers as delivered. Additional charge will be assessed for non-compliance. Nvision Solutions LLC/Le Fabuleux Events will contact the customer if further fees need to be paid regarding replacements, damages or non compliance. Customer shall use all property in a careful and proper manor, shall comply with all applicable laws and regulations, and shall return the property in the same condition and good repair as when received. Customer hereby assumes all risk of loss and damage to the property from any cause whatsoever.

Finalization of Order: Final count and final payment is due two weeks prior to the event. You may change your final count by 15% up or down two weeks prior to your event. After that, no changes are to be made. All payments must be received two weeks prior to the event in order to assure delivery. Nvision Solutions LLC/Le Fabuleux Events will not deliver items that are not paid in full two weeks prior to the event. Any additions of items made less than two weeks prior to your event are subject to an additional 25% fee on the charges for those items.

Third Party Contracts and Other Agreements

We are not responsible for contracts that you enter into with other companies/vendors. We are not responsible and will not be held liable for rules, policies, or stipulations created by venues, hotels and other companies supporting your event that prohibits or limits the use of rental items that we provide for your event.

Cancellations and Changes

The security deposit is non refundable. All cancellations must be dated and received in writing by Nvision Solutions LLC/Le Fabuleux Events. Please be aware that once we reserve an order, other orders may be turned away to honor our commitment to you. In the event you need to cancel an order, your deposit will be forfeited. If cancellation is necessary 35 days or less prior to your event date, an additional restocking fee of 25% of your total order will also be charged.

Returned Checks

Returned checks will incur a \$50.00 processing fee plus additional charges and will be due within 10 days of receipt.

Dispute of Charges

Customer agrees not to dispute any approved credit card charges made by Nvision Solutions LLC/Le Fabuleux Events for balance payments unless our products and/or services are a direct conflict with the invoice and this agreement.
